Edelchemie Benelux BV attaches importance to your privacy.

The entity responsible for the processing, Edelchemie, respects the applicable legislation regarding the protection of private life in the processing of personal data.

Edelchemie processes personal data because you use its services or because you have provided that data to Edelchemie yourself.

Below you will find an overview of the personal data we process:

In the webform under the heading "Contact" we ask to be contacted by email or telephone. The personal data you provide will be used to make a suitable quotation for you and, if necessary, to place an official order. Personal data provided may include, but is not limited to, name, address, telephone number, company name and VAT number.

Edelchemie does not store your personal data for longer than is strictly necessary to achieve the purpose for which the data is collected.

We delete the company data after 10 years of the last order or price request was received. Regarding data of employees at customers or suppliers, these will be deleted upon receipt of a letter of departure from the relevant company.

You have a legal right to inspect and possibly correct your personal data.
